

# Continuing Saga of Drainage at Corner of Aero/Sandrock

City Councilmember Raul Campillo's office was contacted in late November when water was gushing down the gutter from the VA building. The follow-up response from their office:

"The property management had a pump technician onsite Thursday and Friday of last week and apparently they needed to drain the system to perform some diagnostics and repairs. That being said, the property management still has not authorized their engineering firm to initiate work on the low flow pump system, as my last update indicated they had planned to. We are reaching out to the site contact and giving them a deadline of the end of December to have initiated work and made substantial progress. If they fail to meet this deadline, we will escalate our enforcement."

## **Ruffin Canyon Trail Project Update**

Agenda Item for Staff Update at Serra Mesa Planning Group January or February Meeting & Mission Valley Planning Group February Meeting (tentative)

Project Description: The project involves a new approximately half mile trail to connect the existing Ruffin Canyon Trail to Mission Valley via a safe route mostly out of the cobble filled creekbed, with the new trail mostly running along the toe of the eastern slope of the canyon. There is an existing public access easement through the Escala property at the southern end of the canyon to connect to a pedestrian tunnel under Friars Road, leading into Fenton Marketplace. The project has been sitting 3/4 complete and closed to the public for two years. Construction of the trail is limited by a couple factors. It's easier for construction (perhaps cost effective) to occur in the winter, when the soil is moister and construction probably can't occur during the bird nesting season, from Feb 15 to August 15, so there's the Feb 15 deadline each year.

#### Background:

- 2008-2009 the Friends of Ruffin Canyon and Friends of Normal Heights Canyons assist the SD River Conservancy (SDRC- state agency, separate from River Park Foundation) and a consultant in the preparation of a feasibility report on connecting NH and SM to the river via safe trail routes.
- 2010-2013 SDRC moves forward on a planning process for the Ruffin Canyon Trail connection, including circulating a CEQA Mitigated Negative Declaration for public review. SDRC does not move forward due to concerns from Escala at the time and staffing limitations.
- 2014 SMPG Subcommittee develops recommendations for use of the Developer Impact Fees (DIF) from the (now called) Olympus Corsair development at Aero and Sandrock. One of the recommendations was to devote \$100,000 of the DIF funding to city permitting costs for the Ruffin Trail connection. The SM PG and SM Rec Council both adopt this recommendation to the city.
- 2015 After several coordination meetings with prior District 7 staff and other city staff, funding recommendation was applied to the permitting costs by having this use of the funding classified as park equivalency.
- 2020 After a few years of delays, continued advocacy, meetings, etc., the permitting is finalized by the DPR team. Unfortunately, the city was not proactive during the 2015-2022 years, in completing the legal process associated with a needed moving of the Escala easement at the southern end of the canyon to conform with the permitted alignment.
- Winter 2022-2023 3/4 of the trail construction is completed within the city property. From February 2023 until now, the question was raised about what is going on with the contracting for the final construction
- October 2023 City Real Estate Management finalizes the easement change process on the Escala property.
- December 2023 in response to another of many inquiries on the finalization of the construction contract for completion, as we get to the time when construction must start, the city indicates we have to wait on additional grant funding for the last of the construction and the project will be delayed another year (first notification that a grant was even needed).

- Early to mid-2024 more questions on why we can't get the construction contracting finalized to make sure there are no delays this winter. We are told of the need to wait until the new fiscal year.
- August 2024 Serra Mesa and Escala representatives meet with DPR staff and City Councilmember Raul Campillo's representative. DPR notes they will be getting the contract finalized in October and everything is on track for completion this winter.
- 11/13/24 In response to an email seeking confirmation that the construction contract is finalized, DPR notes they were told a completely different contracting process *might* be required this time, which could lead to another year of delay. City Councilmember Raul Campillo's representative has been trying to get more information for the last month, but nothing yet.

Interested residents are encouraged to contact Councilman Campillo's office (<u>RaulCampillo@sandiego.gov</u>) for an update, which can help ensure this remains a District 7 team priority to advocate for more transparency on the current delay, and completion of this funded park equivalency project this winter.

## City of San Diego to Begin Educating Drivers on State 'Daylighting' Law

ENFORCEMENT TO BEGIN JAN. 1, 2025; LAW AIMS TO PROTECT PEDESTRIANS BY LIMITING PARKING NEAR INTERSECTIONS

SAN DIEGO – In order to improve safety on our roads, the City of San Diego is educating San Diegans about a new state law that aims to protect people crossing the street. The so-called "daylighting" law prohibits vehicle parking within 20 feet of any marked or unmarked crosswalk to improve the range of vision of approaching drivers, so they are more likely to see pedestrians, skateboarders and others in the intersection.

The California state legislature passed this law (AB413) in September 2023, and it will be enforceable beginning Jan. 1, 2025. It is important to note that this law allows drivers to be ticketed for violating this rule, even if there is no signage or red curb in the area explaining where parking is prohibited.

For the first 60 days after Jan. 1, 2025, San Diego Police will issue warning notices to vehicles parked in violation of the new law, and ticketing will commence after the warning period concludes.

"This is an important step toward improving safety on our City streets," said Transportation Department Director Bethany Bezak. "Working together, we can prevent needless crashes and save lives, simply by changing how and where we park our vehicles. This new law will bring us closer to our Vision Zero goals, and a future where everyone in San Diego may safely walk and ride."

<u>Vision Zero</u>, a concept adopted by many cities worldwide, aims to eliminate traffic-related fatalities and severe injuries for all road users.

Studies have shown that if drivers have greater visibility at crosswalks, crashes involving pedestrians can be more easily avoided. The law prohibits stopping or parking a vehicle within 20 feet of any marked or unmarked crosswalk or 15 feet of any crosswalk where a curb extension is present. This applies across the state and every applicable intersection in the City of San Diego, whether in an urban or suburban area, residential and commercial neighborhoods alike.

"San Diego's neighborhoods will greatly benefit from the Daylighting to Save Lives Bill, as it removes obstacles around crosswalks, making it easier for everyone to walk to local shops, schools and parks," said Jeremy Bloom, acting CEO of Circulate San Diego. "This law aligns with our city's goals for connected, walkable communities."

Currently, jurisdictions can only issue a warning for a violation and are prohibited from issuing citations, unless the violation occurs in an area marked with red paint or a sign.

However, on Jan. 1, 2025, jurisdictions will be authorized to begin issuing citations for stopping or parking a vehicle within 20 feet of any intersection where a person may cross the road – whether or not there is a marked crosswalk and regardless of whether the curb is painted red to indicate the no-parking area.

Work has already begun at intersections in the City with high pedestrian and vehicular traffic, in the form of red curb paint and signage prohibiting parking. However, as a practical matter, not all City curbs will be able to be marked.

The new restrictions also impacted 164 parking spaces with meters. Parking meters have already been removed from 97 spaces, mostly downtown. Another 67 meters were moved slightly so they would not fall inside the 20-foot restricted zone near intersections.

Nationwide, 43 states already have daylighting laws, and most prohibit parking within 20 feet of an intersection.

## San Diegans Invited to Join the Conversation During Second Phase of Trash Study Outreach

#### City of San Diego Kicks Off Community Meetings With Insights Gained So Far

As the City of San Diego enters the second phase of community listening sessions for enhanced trash collection services and potential new fees, San Diegans are once again invited to participate in the process. During Phase 2 of the Trash Study outreach for residential customers serviced by the City's Environmental Services Department (ESD), the City will host meetings in each Council District, starting Nov. 12, to share what has been learned so far and to gather additional feedback. (Meeting scheduled for January 28, 6:30 pm, at Serra Mesa-Kearny Mesa Library.)

The City's robust Trash Study community engagement kicked off in August 2024 with a series of open house meetings designed to gather diverse perspectives and build an understanding of preferences. Community members living in residential properties currently serviced by ESD were invited to learn about the history of waste management in San Diego, find out how services are presently funded, and to share their thoughts and views about the services they currently receive.

In Phase 1, the City heard from more than 6,000 residents through events, surveys and monthly meetings with leaders from several community-based organizations. The City also completed much of the financial work that will inform recommendations to the City Council.

"We are very pleased with both the quantity and quality of what we've learned so far," said Andrea Deleon, Deputy Director, Environmental Services Department, Waste Reduction Division. "We heard from thousands of people about the current services they receive and what enhanced services they would be interested in. Several themes came up again and again as priorities, including bulky item pickup, increased recycling collection and replacement of broken bins at no additional charge. This kind of insight is invaluable as we move forward with this first-ever, historic opportunity to engage with San Diegans about waste management."

Another key takeaway from Phase 1 engagement is the desire for ongoing education and outreach for how to properly dispose of trash, recyclables and organic waste. These insights will be considered as the City moves toward Phase 3 (another round of meetings and the completion of an extensive Cost-ofService Study) in spring 2025, leading up to the City Council considering a proposed fee schedule in June 2025.

Phase 2 meetings will consist of a brief overview to include priorities expressed by residents and a comparison of trash and recycling services and charges in nearby cities. An open house will follow, during which

participants can review the data, ask questions and provide feedback. Spanish speakers will be on site to provide translation at each meeting. Requests for other language translation services can be made in advance.

A virtual meeting, in English and Spanish, was held on Dec. 6. In addition, community members are invited to take a second questionnaire that builds on an earlier version to help the City better understand their views about trash, recycling and organic waste collection services. Residents who prefer more formal presentations of study information can attend meetings of Community Planning Groups and Town Councils where the Trash Study is on the agenda. The City also continues to host tables at farmers markets and other community events. A complete schedule is available at cleangreensd.org.

The City's Trash Study comes as a result of <u>the passage of Measure B in 2022</u>, amending the "People's Ordinance" to allow the City to charge a cost-recovery fee for trash and recycling collection services. Such a fee would apply to approximately 285,000 residential properties currently serviced by the City. This includes single-family homes and residential complexes of four or fewer units that meet City requirements for City-provided trash and recycling collection. Currently, these properties do not directly pay for trash and recycling collection, while residents in apartment complexes and those with homeowner associations, for example, do pay private waste collection companies for these services.

# Local prison book program brings connection and humanity despite censorship

Cherish Burtson remembers when books were her only escape. She was incarcerated at the Federal Correctional Institute in Dublin, Calif.

"And I went through so many books; I think that's the only thing that allowed me to actually get through it," Burtson said.

Now, Burtson volunteers with Books Through Bars were her only escape.

San Diego, a mutual aid collective that sends books to prisons. The group holds regular packing events at Groundwork Books at UC San Diego. Volunteers open

letters from incarcerated people, select books and write letters back.

This year, the group received about 150 letters per month. They shipped 1,200 books to incarcerated people in 200 facilities across 40 states.

"When you're in there, you're just at a complete standstill and you really feel like the outside world forgets about you. And it's those little things — letters and books — that make you feel like you actually still are a part of the world," Burtson said.

Books Through Bars operates with minimal overhead. It is

volunteer-run and relies on word-of-mouth and prison resource lists to spread the word. Groundwork Books donates storage and event space for packing events. Books are donated by the community and bookstores, with donations sites scattered throughout the region.

Another volunteer with Books Through Bars, Terry Vargas, said the busiest book donation sites include Libélula Books, the Friends of Serra Mesa Library and Groundwork Books.

The group's primary expense is shipping. It costs roughly \$5 to send each package of books, which added up to \$6,295 in shipping costs in 2024. To raise money, the group recently published and sold zines of art sent by incarcerated people along with their book requests.

Organizers say about 70% of their packages make it through security.

Prisons routinely censor books. According to a 2023 study by PEN America, correctional facilities in all 50 states contribute to the nation's largest book ban. Many states, including California, keep a centralized banned book list. In other

states, the list is vague and less predictable. Books containing sexuality, nudity, violence or content that may be a "threat to security," certain DIY instructions, or stories about life in prison are often censored, according to PEN America research.

Researchers found that, in addition to banned book lists and categories, censorship also exists from on-the-spot judgment from facility mailrooms, and "content-neutral" censorship — a catch-all for other reasons an incarcerated person may not be allowed to receive a book. This may include used books, hardcovers, improper mailing practices or failure to comply with facility mailroom procedures.

The rules for book shipments vary widely and are hard to track. "Facilities are becoming stricter and stricter with the requirements — some facilities have adopted requirements where they only accept white envelopes — and these are just like arbitrary rules, just add barriers for us to be able to send these packages," Vargas said. But for Books Through Bars, it's worth the effort.

The packing events are powerful for the volunteers, too. "I think that impact goes two ways," Burston said. "Just being able to actually read people's words and know that we are making some kind of difference, no matter how small," she said. "So actually showing up for people who are incarcerated and building that

connection with them — which reading their actual words forces you to do — that was really powerful for me."

A letter from an incarcerated person is shown on Dec. 7, 2024. It reads "I am writing to request books. I really appreciate the work your organization is doing for prisoners. It really helps me not lose my cool. Saves my life, really."

Letters from incarcerated people often express gratitude, Vargas said. At a recent packing event, she opened a letter from Zachary in Indiana, written on a torn half-sheet of binder paper. "He says, 'I'm writing to request books. I really appreciate the work your organization is doing for prisoners. It really helps me not lose my cool. It saves my life, really," Vargas read.





#### Serra Mesa Projects

**Franklin Ridge Road Connection** – Schedule for implementation of mitigations and road connection pending. The developer submitted a design plan for 5 travel lanes and 2 bike lanes for the Murray Ridge bridge (the configuration that's described in the approved October 2017 plan). This differs from Caltrans' draft plan which describes the redesign of the Murray Ridge bridge as 4 travel lanes (11' wide) and 2 Class IV Bikeways (9' separated for each bikeway). Also, other city-approved mitigations include 5 travel lanes and 2 bike lanes for Phyllis Pl from the Franklin Ridge connection to the bridge, and 4 travel lanes and 2 bike lanes for the connection.

**AT&T Wireless Communication Facility, 2696 Melbourne Dr** – 40' high tall faux eucalyptus tree; 12 antennas, 9 remote radio units; 300-foot ground level equipment enclosure, faux rock; located near labyrinth.


