President's Column

Dear Members of the Serra Mesa Community,

Thank you for your active participation and engagement at the recent Serra Mesa community meetings. Your contributions were invaluable and helped to foster a productive discussion with our local representatives.

Recently, I've received quite a few messages from concerned community members regarding several issues: 3440 Sandrock Project, traffic congestion concerns, City budget, Ruffin Canyon Trail, and many other issues. I've passed on these questions and concerns to our local representatives, and we hope they will work with us on good solutions.

3440 Sandrock Project: Several community members have been expressing concerns about the upcoming project that has been well documented in our newsletters. While the Serra Mesa Planning Group and Community Council supports housing for veterans, affordable housing and the original much smaller proposal, we were surprised and distressed to see this massive 60-unit complex proposal a few months ago. We are hoping that our elected representatives listen to our community's voices and concerns to address this property in a way the majority of the community would support.

Traffic Congestion: Our community will become much more populated in the upcoming months. Take a look at all the upcoming new homes on Aero drive, new buildings by Taft, etc. Please be careful approaching those roads and intersections. During the Town Hall meeting at Stonecrest Club house earlier this month, many of the Serra Mesa residents mentioned these concerns to our Councilman.

San Diego City Budget: It's budget season for our city. We anxiously await to see what roads will be fixed, what programs will be cut, retained, etc. I attended an interesting city budget meeting this past week in Mira Mesa. When it was time for questions, the packed crowd all had similar concerns- Infrastructure, Public Safety, Economic Development, and wasteful government spending. The presenters were said to be independent auditors. Please take some time to look through the document in this link below. Is there anything here you think we should cut or reduce? We are facing an approximately \$258 million deficit in San Diego. I encourage you to reach out to our representatives with your ideas on which items you'd like to see reduced or outright eliminated. Otherwise, we may start experiencing higher taxes and other increased fees and costs.

Trash Collection (Measure B): Speaking of costs, keep a lookout in your mailbox from March to May for an important mailer from Trash Collection services in San Diego. Assuming our City Council approves this new fee (which is likely), the taxpayers will have a final chance to have their voices heard by returning these mailers if they'd like to oppose the fee. If homeowners would like to stop the fee, homeowners would need to return more than 50% of the total mailers that are sent out at that time. Please encourage others to get involved as this one has a direct effect on homeowners' wallets!

SMPG meets the third Thursday of the month, 7 pm, at the Serra Mesa-Kearny Mesa Library, 9005 Aero Drive, and via online meetings. Elections: SMPG's bylaws allow fifteen Board members. On March 20, 2023, SMPG will conduct an annual election for board members for two-year terms. Anyone who is at least 18 years old, affiliated with the community as a property owner, resident of Serra Mesa, or a local Serra Mesa business person. The City provides training. See https://www.sandiego.gov/planning/community/resources.

Current SMPG board members are Debra Burns, Kira Finkenberg (Secretary), Wayne Harris, Joe Ippolito, Sharon Kramer, Carey Longley, Cindy Moore, Chris Rosemond (Vice-Chair), Jason Schneider, and Catherine Stempel (Chair). Board member termed out is Cat Stempel. Board members up for reelection are Deborah Burns and Kira Finkenberg.

Updates

Ronda & Mission Village Drive, Feb 20: SMPG passed motion on Feb 20 to move u-turn from Ronda and Mission Village to Shawn and Mission Village. At the Jan 16 meeting it was reported that traffic engineers conducted a study and recommended that a streetlight be placed at this intersection; listed in the City's unfunded list.

Amend SMPG Bylaws, Feb 20: SMPG passed motion to amend the bylaws to include hybrid meetings. Amended bylaws are at https://www.serramesa.org/smpg/smpg-documents/.

3440 Sandrock Rd, Feb 20: SMPG passed several motions. See article in this Observer edition.

Birdland Development Project, Feb 20: San Diego Unified School District is planning to request proposals from developers to build a housing project at 2442 Cardinal Lane for district employees. SMPG decided to send an email to SDUSD requesting notices of meetings and information about the Birdland building project.

Ruffin Canyon Trail Update, Jan 16: Presentation made by Kevin Johnston. Refer to the article in this Observer edition.

Trash Service Study, Jan 16: The presentation made by Environmental Services Department to SMPG and SMCC on Jan 28 is at https://www.serramesa.org/news-events/. It's anticipated that between April -May notices will be sent to residents who will receive the new trash service. After mailing there's a 45-day period to protest the proposed fees.

Future Agenda Items: Request by resident to name alley adjacent to Macawa after a relative. Request by resident for discussion/action on density.

Managing Our City's Budget

In November, voters were given the opportunity to aid in reducing the budget shortfall that is now facing the City of San Diego. If approved, as was proposed by Measure E, sales tax would have increased by 1% (currently 7.75%), and generated needed revenue toward our infrastructure deficit.

Infrastructure is defined as the basic systems and facilities that support our community. It includes the resources and services needed for the area's economy, households and businesses to function. Funding is essential for basics like sidewalks, streetlights, water quality, and the staffing needed to maintain them. Although the vote was close, the measure did not pass. Possible reasons for its failure are that folks are just tired of yet another tax increase. Or, there are those who feel poor City management has gotten us into this mess, thinking it could have been prevented by taking different paths during past budgeting processes. Some say the vote was simply a battle of the haves and have nots.

The question now is how the City will manage the budget shortfall of nearly a quarter of a billion dollars, and take us forward productively. Neighborhood residents were invited to join in hearing information and sharing ideas on this topic by attending sessions held throughout the City. Citizens Budget Review Town Hall meetings were offered and presided over by Independent Budget Analysts. It was a chance for residents to ensure their voices were heard during the City's budget process now and in the future.

Residents attending learned about the budget process including categories and amounts of underfunded services. Did you know only 17 cents of your property tax dollars goes into the City's general fund? Other areas, such as state, counties and schools get theirs first.

The meetings were informative and interactive. We were allowed to make inquiries, suggestions, and share input directly with the City. The question attendees were invited to answer - Now that Measure E has failed, where should City budget cuts be made?

Hats off to City officials who gave us this meeting opportunity, and, at times, faced an angry mob. There was a willingness to admit past budgeting mistakes and learn from them. Like our City streets, the road coming during the next fiscal year looks to be a rough one. Let's work together to smooth out edges where we can.

Let's Talk Trash

Are you excited about the opportunity to start paying for trash collection at your curb? Think not. The new fees proposed will be added directly on to your property tax bill, and possibly in the amount of \$53 per month per household. Sounds frustrating when we thought that was already covered in our tax bill.

Studies held this past year on charging residents (for the first time) are concluding now. Collection of fee amounts decided upon will begin shortly. It's not usually the case when you have to pay more for something that you have any control over it. Now you do. Shortly, the City will be sending out a mailer to every property tax payer. You will be given the right to return the ballot saying no to the increase. If enough NO votes are returned, the charges will not be implemented. Failure to return your vote counts as a yes, and the fees will begin.

Watch your incoming mail for this notice, and take a stand. There's more than junk mail coming our way.

3440 Sandrock Project—SMPG Motions

Serra Mesa Planning Group passed the following motions on Feb 20, 2025:

- Serra Mesa Planning Group (SMPG) supports housing for veterans, affordable housing, and the original proposal of 30 units multi-family housing and with at least 22 parking spaces at 3440 Sandrock Road.
- Serra Mesa Planning Group (SMPG) authorizes the 3440 Sandrock Subcommittee to evaluate, make comments, and ask questions regarding the development agreement/lease and financing documents for 3440 Sandrock Rd if any City Council related hearing is scheduled prior to the next scheduled SMPG meeting.
- Serra Mesa Planning Group send a letter to the City Council's Economic Development & Intergovernmental Relations Committee urging them to deny a City Bridge to Home NOFA of \$3.5 million if any unanswered questions and concerns regarding the development agreement/lease and financing have not been addressed and resolved. The questions and concerns include, but are not limited to (possibility of additional concerns/questions when the development agreement/lease becomes available for review):

Affordability Mix – If there are only 43 units requesting funding for \$3,500,000, why does the documentation indicate \$58,333 per unit (which seems to be based on 60 units)? Shouldn't the documentation indicate \$81,395 per unit? In the development and lease agreement will the 43 and 17 units be treated differently?

Financing

- Provide a comprehensive breakdown of the costs of the project for the City, including loans, grants, and waivers; and any additional federal and state grants the project will receive. Is the City waiving the ground lease? Is the City waiving fees? Who is paying for deferred interest?
- Why doesn't the City wait until the Federal Tax Credit of \$22,497,750 is approved before loaning funds? What happens if the applicant isn't ever able to obtain the credit?
- Are project operations dependent on receiving vouchers for any of the units? Are the funds for these vouchers in hand and secure from state and/or federal freezing or withdrawal?

<u>Project Size</u> – Provide a diagram that shows the lot size, amount of space for 22 parking spaces, the amount of space for the building structure, and the height of the structures. There are concerns about the feasibility of this project with the required setbacks, 22 parking spaces, landscaping, and 60 units given the .34 acre lot.

NOFA's Evaluation Criteria for scoring applications

Project Approach and Concept state "Application is consistent with the community plan...as indicated by...overall project concepts, layout, extent of neighborhood enhancement..." What are the neighborhood enhancements? 3440 Sandrock Project—SMPG Motions continued from previous page

The Serra Mesa Community Plan, under Proposals, p. 9 &10,

- "The proposed maximum density of existing development is 43 units per net acres; that for new development, 29 units per net acre." The density for this project is 176 units/acre.
- "New multifamily construction should be continuous to existing shopping facilities and multifamily developments...All such development should incorporate good design standards in relation to building location, parking and landscaping." There are concerns regarding incorporating good design standards in this project.
- Community Support and Benefits describes 3) Other community or economic benefits, or community amenities based on proposed project uses; 4) Community outreach plan to solicit neighborhood input. What community amenities will be provided? What's included in the outreach plan?
- Environmental Review and Assessment states "Prior to the City's funding commitment, projects must be assessed in accordance with the California Environmental Quality Act (CEQA)." What assessment was made? Was there a traffic study conducted and when was it conducted? If conducted, provide the results.

Update for 3440 Sandrock Rd (old library site)



Background: When library moved in

2006 community requested community center at Sandrock site.

Oct 2020 – Community HousingWorks (CHW) was selected to build 29 units for chronically homeless youth and adults.

July 2021 – City Council passed resolution (R-313625) to declare the site as exempt surplus land "contingent upon council's future discretionary approval of a lease of the property for development of affordable housing".

Oct 2023 – Proposal to sell land to CHW for \$15,000 to build 60 units of affordable housing.

Aug 2024 – CHW proposes leasing Sandrock site and building a **5-story elevator building on .34 acres with 60 units** (56, one-bedrooms; 4 two-bedrooms); **22 parking spaces**. 30 units for veterans and 1 manager unit). Project can be built by right*.

Community Concerns: Insufficient Parking Spaces, Setback, Building Height, Lack of Landscaping

Community Response:

Aug 2024 – Serra Mesa Planning Group (SMPG) rejected the CHW proposal and voted to support an alternative proposal to renovate the building as a youth center.

Sept 2024 – Serra Mesa Community Council (SMCC) voted to support this position.

Jan 2025 – SMCC subcommittee met with Councilmember Raul Campillo and discussed community concerns along with financial concerns. Subcommittee's presentation at https://www.serramesa.org/hot-topics/. Councilmember agreed to follow-up on legal and regulatory questions/issues.

Ruffin Canyon Trail Project Update

Ruffin Canyon Trail Connection Update

The Ruffin Canyon Trail Connection project involves a new approximately half mile trail to connect the existing Ruffin Canyon Trail to Mission Valley via a safe route mostly out of the cobble filled creekbed, with the new trail mostly running along the toe of the eastern slope of the canyon. This became a city project following Serra Mesa Planning Group and Rec Council recommendations on use of development impact fees in 2014. Though the development impact fees that funded most of the project were paid over 10 years ago, the connection is not yet complete, with construction 3/4 complete two years ago and no construction progress since then. Part of the mitigation for the project was to close off the northwest section of our existing trail (Gramercy leg), with that closure happening over two years ago. For further details on the background, please see the January-February issue of the Observer.

Update information:

After the end of the program at Councilman Campillo's February 5 Serra Mesa Town Hall, one of the members of Friends of Ruffin Canyon (FRC) was able to briefly talk to the Councilman. Councilman Campillo had just received an update from staff with information on the latest delay, that volunteer advocates had been trying to get since early November. Apparently, during the process to finalize the construction contract (for the remainder of work) this past fall, a small bridge planned over a natural drainage in the southern end of the alignment triggered review by Engineering and Capital Projects (ECP) as something that could potentially require ECP taking over that component and significant delay again. The Councilman said that it was finally back with Department of Parks and Recreation (DPR) with approval to move forward at that point, but with the February 15 start of bird nesting season approaching (this type of construction is understandably not allowed during nesting season), the project would have to be delayed yet another year to next fall/winter. The FRC member let Councilman Campillo know there was also small bridge constructed over a drainage in the construction completed over two years ago, and they both wondered how that was different. The fact that this coordination with ECP was not possible for the two years leading up to November 2024 and then it took until right before the start of nesting season this winter to get it figured out, leaves many questions and concerns on whether this could be more about priorities.

A couple longtime advocates (one from Serra Mesa/FRC and another from Mission Valley-Escala HOA and MV Planning Group member) have requested a meeting for later this spring, to include Councilman Campillo and representatives from DPR and Purchasing and Contracting. These advocates had a meeting with DPR and the Councilman's staff in August 2024 with assurances from DPR that everything was on track for completion this winter of 2024-25; however, this of course wasn't the case. Advocates have not yet been able to get the Councilman to join any of these meetings yet, in the years since he's been in office. The Councilman's team has responded that they will try to get the meeting scheduled but no guarantees on the Councilman being able to make it to a meeting requested for late April or early May. Advocates are concerned based on last year's experience, that without a representative from Purchasing and Contracting and the Councilman present, we may end up with the same assurances and then yet another unforeseen issue arising when it's time to start final construction in the fall, as happened in fall 2023 and fall 2024.

At this point, it seems Serra Mesa and Mission Valley may be perpetually stuck with a 3/4 complete trail that is

closed to the public if more people aren't emailing Councilman Campillo's team and the Mayor's team to request an update on a monthly (or even weekly) basis this spring and summer. Even though the project is fully permitted and fully funded for completion, it seems having just a handful of stakeholders regularly advocating for completion is not enough to keep it from potentially falling to the bottom of staff priorities (for getting the construction contract ready in time) year after year.

We simply need more people pushing for this and letting the city know completing our long-promised park and recreation improvements is a critical part of addressing the impact of all the residents being added to our community with the large housing projects under construction.

This will be a great project to connect Serra Mesa and Mission Valley via a safe trail connection, with all the benefits of enjoying, appreciating, and encouraging stewardship of the natural habitats in our cherished Ruffin Canyon.

Franklin Ridge Road Connection – Schedule for implementation of mitigations and road connection pending. The developer submitted a design plan for 5 travel lanes and 2 bike lanes for the Murray Ridge bridge (the configuration that's described in the approved October 2017 plan). This differs from Caltrans' draft plan which describes the redesign of the Murray Ridge bridge as 4 travel lanes (11' wide) and 2 Class IV Bikeways (9' separated for each bikeway). Also, other city-approved mitigations include 5 travel lanes and 2 bike lanes for Phyllis Pl from the Franklin Ridge connection to the bridge, and 4 travel lanes and 2 bike lanes for the connection.





Regulations – Encroachment into side and rear yards, no parking required; maximum size 1,200 s.f., rental term minimum 31 days, major fees waived, owner doesn't have to live in premises. Number of ADUs permitted on single family property is one but the Bonus ADU Program allows for additional ADUs.
